## **No Deforestation Commitment**

# **Objective**

Forests are a critical part of the natural ecosystem and an important global carbon sink due to their ability to absorb and store greenhouse gases from the atmosphere. Protecting forests helps mitigate climate risks, improve climate change resiliency, and safeguards biodiversity. GGP's products rely on climate, supply chain, and agricultural ingredients. Since we do not clear forests to carry out our production, we still have a role to play in combatting deforestation (no gross deforestation) and its associated impacts on commodity-producing landscapes and the communities where we live, work and source our ingredients. We are declaring our commitment and taking a comprehensive approach to ensure the long-term sustainability of our business and to do the right thing for our shared planet.

### Scope

No deforestation commitment applies to all business unit of PT Great Giant Pineapple. This policy applies to our entire raw material supply chain, including direct and indirect suppliers, at a corporate group level.

### **Definition**

- No gross deforestation: Also referred to as zero or zero-gross deforestation, it refers
  to voluntary commitments to stop or reduce all deforestation associated with
  commodities that they produce, trade, and/or sell.
- Suppliers are all parties who supply raw materials and services, both from local and imported suppliers, who have been selected based on procedures applicable to the Company.
- The "Company" means PT Great Giant Pineapple and all its business unit.

### **Policy Statement**

Our commitment is to address end deforestation (gross deforestation) in our operations, supply chain, and build a regenerative farming system within the company. In dealing with deforestation, GGP focuses on the following aspect:

- 1. The Company shall complete a value chain structure that operates a business without deforestation in the mid-to-long term.
- 2. The Company regularly monitors the risk of deforestation occurring during the sourcing process of raw materials in the mid-to-long term.
- 3. The Company recommends that suppliers monitor and mitigate deforestation risks during business operation as part of the 'Supplier Code of Conduct.' The Company shall



- complete a value chain structure that operates a business without deforestation in the mid-to-long term.
- 4. The Company has established supplier qualification assessments and requires suppliers to comply with sustainability and procurement policies, particularly forest product use in their value chain. The Company also provides that the Company's supplies come from legal sources and prevent encroachment on protected areas by applicable legal requirements.
- 5. The Company, through Regenerative Agriculture implementation, preserve natural ecosystems by regenerating natural resource (soil and water) and safeguards biodiversity by maintaining a conservation zone in our operation site.
- 6. The Company shall offset the remaining greenhouse gas emissions through carbonoffsetting activities by 2050.
- 7. The Company prohibits the hunting of animals and plants in its operational areas and preserves the ecosystem as a place for non-production animals and plants to live.
- 8. The Company ensures that the paper-based packaging is packaging whose materials are produced from forests that are managed responsibly, both environmentally and socially. The Company collaborates with all types of suppliers to force the green packaging implementation.
- 9. In controlling pests and diseases in plantation companies, The Company applies Integrated Pest Management (IPM), a pest control method that prioritizes nonchemical, biological, and physical use in plant care process.
