



## Biodiversity Commitment

### Objective

PT Great Giant Pineapple (GGP) is committed to continuously preserving biodiversity around our operational areas as part of our responsibility to mitigate the potential impacts of our operations. This policy acts as company guidelines related to comprehensive biodiversity management at GGP.

### Scope

This biodiversity policy applies to all operations within the scope of PT Great Giant Pineapple, and including tier-1 suppliers and non-tier-1 suppliers' operations in the supply chain of the corporate hereinafter referred to as the 'relevant stakeholders'.

### Definition

Biodiversity is the variation among living organisms from different sources including terrestrial (above land) and under water and the ecological complexes of which they are a part.

### Policy Statement

1. The company and relevant stakeholders are dedicated to preventing biodiversity loss (No Net Loss) and aims to generate Net Positive Impacts in 2030 across its entire value chain.
2. The company is committed on critical areas\*\* with the aim of ensuring that operations do not result in biodiversity loss (No Net Loss) in those regions.
3. The company and relevant stakeholders are committed to maintaining biodiversity around operational areas and areas adjacent to conservation zones.
4. The company and relevant stakeholders are committed to maintaining biodiversity conservation, which is realized by carrying out an initiative to map land and water biodiversity related to microfauna, fauna, and flora ecosystems at several active sites in the company's area.
5. The company is committed to measuring, setting objectives, and establishing reporting and monitoring systems, both internally and through partners, to ensure compliance with the commitments set out in this Policy.
6. If the company operational activities near to site containing globally or nationally important biodiversity, it will manage these risks using the Mitigation Hierarchy (reduce, regenerate, restore & transform, avoid). This approach prioritizes avoiding significant impacts on biodiversity and supports the No Net Loss strategy.
7. The Company holds training and builds awareness regarding biodiversity management for all elements of business units, employees, and suppliers.



8. The Company and relevant stakeholders are actively collaborates with stakeholders, including local communities, to preserve the ecosystem through preventive, mitigation, and biodiversity restoration efforts.

### Conservation and Protection Action

1. No Deforestation

The Company prohibits logging activities of natural trees and the destruction of conservation areas around operational areas. Company engages with suppliers to encourage them using green practices approach.

2. Prohibit Hunting

The Company prohibits hunting, provocation, catching, or selling wild animals around the plantation area and operational sites.

3. Bio Pest Management

The Company prohibits use of explosives and toxic materials to destroy pests and to prevent exposure to the adverse effects of these toxic materials on the environment.

**\*\*Focus on critical areas, specifically the GGP Lampung operations, including Plantation Groups (site) 1-4 and the canned pineapple manufacturing facility, with the aim of ensuring that activities in these areas do not result in biodiversity loss (No Net Loss).**
